

**“104.9 the River’s ‘The Gifted Wedding’ Contest”**  
**PRESENTED BY WCVO-FM, COLUMBUS PROMOTION OFFICIAL RULES**

1. **PROMOTION TIMING:** The contest will begin at 12:01 am on MONDAY, JULY 1<sup>st</sup>, 2019 and end at 11:59pm on SATURDAY, AUGUST 31<sup>ST</sup>, 2019. (“Promotion Period”). The nomination period for the promotion begins at 12:01am on MONDAY, JULY 1<sup>st</sup>, 2019 and will end at 11:59pm on WEDNESDAY, JULY 31<sup>ST</sup>, 2019. The voting period for the promotion begins at 8pm on WEDNESDAY, AUGUST 14<sup>TH</sup>, 2019 and will end at 11:59pm on SATURDAY, AUGUST 31<sup>ST</sup>, 2019. The contest may end without prior notice.
2. **HOW TO ENTER:** Listeners of 104.9 the River (WCVO) will be given the chance to nominate a couple who is serving Columbus online at [www.1049theriver.com](http://www.1049theriver.com). 104.9 the River will accept nominations from 12:01am on MONDAY, JULY 1<sup>st</sup>, 2019 until 11:59pm on WEDNESDAY, JULY 31<sup>ST</sup>, 2019. Three (3) Finalist Couples will then be chosen at the station’s discretion. Beginning at 8pm on WEDNESDAY, AUGUST 14<sup>TH</sup>, 2019, the public will have access to vote for their favorite finalist couple at 1049theriver.com. Voting will close to the public at 11:59pm on SATURDAY, AUGUST 31<sup>ST</sup>, 2019. Limit one (1) vote per person. Promotion is limited to one entry per household. Any entry or entries not in compliance with the Official Rules shall be deemed ineligible. By providing any personal information, you acknowledge that River Radio Ministries or Thrivent Financial may send you information, samples or special offers it feels may be of interest to you. Promotion is open to all legal residents of the United States who are 18 years of age and older, as of date of participation.
3. **NO PURCHASE REQUIRED:** No purchase is required to enter or be eligible to win a prize.
