

**104.9 THE RIVER'S "RIVER SPELLING BEE" CONTEST  
PRESENTED BY WCVO-FM, COLUMBUS PROMOTION OFFICIAL RULESPROMOTION**

- 1. TIMING:** Promotion takes place select weekday mornings between 6am and 9am unless otherwise stated. ("Promotion Period").
- 2. HOW TO ENTER:** Listeners of 104.9 the River (River Radio Ministries) are prompted to be the 9th caller to the 104.9 the River studio at 614-479-1049 to participate in the River Spelling Bee contest for a chance to win a prize valued at \$25 minimum (prizes change weekly and are subject to change daily). Any caller not in compliance with the Official Rules shall be deemed ineligible. By providing any personal information, you acknowledge that River Radio Ministries may send you information, samples or special offers it feels may be of interest to you. Promotion is open to all legal residents of the United States who are 18 years of age and older, as of date of participation.
- 3. NO PURCHASE REQUIRED:** No purchase is required to enter or be eligible to win a prize.
- 4. ODDS OF WINNING:** Odds of winning are determined upon the number of callers and will to adhere to other conditions outlined in the Official Rules. Decision of station is final in all respects.
